

Dream Escape Holiday Competition

How to enter

1. Information on how to enter and prizes form part of these terms and conditions of entry (**Terms and Conditions**). Entry into the Competition is deemed acceptance of these Terms and Conditions.
2. The Competition commences on the 23/02/2016 at 9am (AEDT) and concludes at 5pm on 20/03/2016 (AEDT).
3. Entry is open to all Home Timber & Hardware Group (Home Timber & Hardware and Thrifty Link Hardware) retailers in Australia 18 years and over. Company owned Home Timber & Hardware stores, employees and their immediate families of the Promoter and their associated agencies and companies are not eligible to enter.
4. One qualifying winning entry per store will be awarded the prize. The business owner may at their discretion decide who takes the prize
5. Entrants are required to purchase Outdoor Furniture and BBQ Products from the new season collection launched on 23/02/2016 and achieve a level of purchasing volumes to gain entry into the draw. General terms
